• As a Community Relations Officer and Surge Capacity Specialist for FEMA, Mr. Markley is responsible for community outreach and liaising with federal agencies throughout the duration of a large-scale event. Under this discipline he trains Other Federal Agencies (OFA'S) in the FEMA response effort.

### **Emergency Management Agency**

During his 7 years as the Richland County EMA Director.

- Mr. Markley spearheaded numerous projects that involved collaboration with the community and response disciplines including developing a county-wide Emergency Operations Plan (EOP) and a Hazard Risk Assessment.
- He also created a Homeland Security Terrorism Task Force to oversee the use of Homeland Security Grant Funds.
- Developed the Richland County Community Emergency Response Team (CERT).
- Created Richland County's first permanent Emergency Operations Center (EOC)
- Implemented a new county-wide 911 Dispatch Center including the deployment of the county-wide Phase II Wireless 911 System.
- Oversaw the process for Richland County to become a Storm Ready county which included providing education to citizens, organizations and agencies throughout the county.
- Mr. Markley worked with all local officials to include but not limited to county commissioners, local mayors, heath department officials, hospital officials, Red Cross and United Way.

For 27 years, Mr. Markley served the largest township in Richland County as a Madison Township Firefighter.

- In the role of Training Officer Mr. Markley was responsible for identifying training needs utilizing basic gap analysis methodologies and developing training programs based on the gaps between current and desired training. Mr. Markley worked to develop and implement safety training standards as well as training for all new recruits. At one point Mr. Markley had personally trained over 80% of the department's members as new firefighters.
